- Many of the challenges young people face such as family stress, personal safety, or social disconnection — don't start in schools, but they often show up in the classroom and at the front desk.
- Issues inside the school system, such as **bullying**, **peer pressure**, **and inclusion**, directly affect student wellbeing, engagement, and learning outcomes.
- Teachers, support staff, and reception teams are often the first to feel the ripple effects of these pressures, sometimes without the tools or frameworks to respond confidently.
- School leaders carry the responsibility of balancing student wellbeing, parental expectations, compliance, and reputation – often in complex, high-pressure situations.
- Even in independent and private schools, where students may appear wellresourced, hidden challenges and high expectations can place young people and staff under significant stress.

What We Offer

At Everyday Human Rights, we provide **meaningful, engaging and immediately actionable human rights education** to professionals, stakeholders and young people about how to use human rights to create a better, safer and fairer society.

- Human Rights In Practice (For Professionals) is designed for leadership, administration, teaching and support staff to strengthen staff awareness and understanding of how human rights applies to their personal and professional lives.
- Human Rights in Action For Young People fosters in students crucial understanding and self-advocacy skills that are relevant to themselves, their families and their communities throughout their lives.

How We Help

Human Rights in Practice for Professionals (Foundations) Education

These roundtable workshops promote a critical understanding of human rights theory for all advocates of young people. The series covers its key concepts and how these apply to individuals, organisations and governments – in the real world.

The format is **an experiential 6-hour session** outlining the key concepts of human rights and includes time for reflections and discussion.

It aims to **empower staff, equip them** with a current and relevant understanding of human rights in practice, build skills on how to effectively negotiate human rights provisions in their day-to-day work, and provide mechanisms for integrating the standards in their work to protect and promote human rights.

Topics covered:

- What we know about human rights
- What human rights mean to each of us at work, home and in the community
- The unique value of the human rights framework for advocacy of self and others
- How do we use key messages about human rights principles in our everyday lives
- Who is responsible for promoting and protecting human rights for all
- How do we assess and identify human rights risks or breaches
- · Reflections and discussion



By the end of the series, participants will have the capacity to use the human rights framework processes, including human rights risk assessment, to assert accountability following current legislative and regulatory provisions.

Specific learning objectives include understanding the human rights assessment process, identifying areas of human rights concern, and assessing the result of poor human rights practice.

- strengthened capacity to support young people to understand their rights and responsibilities better, and support personal or community advocacy as needed.
